CONNECTIONS Application Downtime

On January 23, 2009, OCFS will implement the Q4-08 Quarterly Improvement Plan. In order to migrate the new functionality to production, the CONNECTIONS application will not be available from Friday evening to Saturday morning. The specific schedule of application downtime will be communicated soon.

Q4-08 Improvement Plan

Q4-08 will include important enhancements to the CONNECTIONS application that support programmatic changes, some ease of use enhancements, and several system improvements. The major ease of use enhancements included in Q4-08 are recommendations from the Child Welfare System Transformation Business Team. The enhancements come from collaborative between OCFS, local district and voluntary agency casework and supervisory staff. Here is a list of the enhancement areas: Family Services Stage, Approvals, Permanency Hearing Report (PHR), Progress Notes, Investigation Stage, Foster and Adoptive Home Development (FAD), as well as System Messaging.

Q4-08 Highlights Document

The *Q4-08 Highlights* document presents a high-level overview of programmatic and application modifications and enhancements. It is one in a series of tools that define and describe in detail the system changes and enhancements that will be included in this Quarterly Improvement Plan. The *Q4-09 Highlights* will be available mid-week of this coming week.

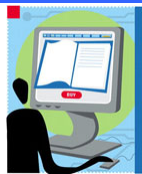

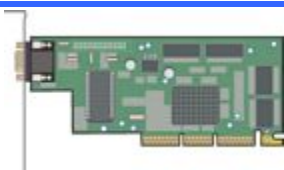
