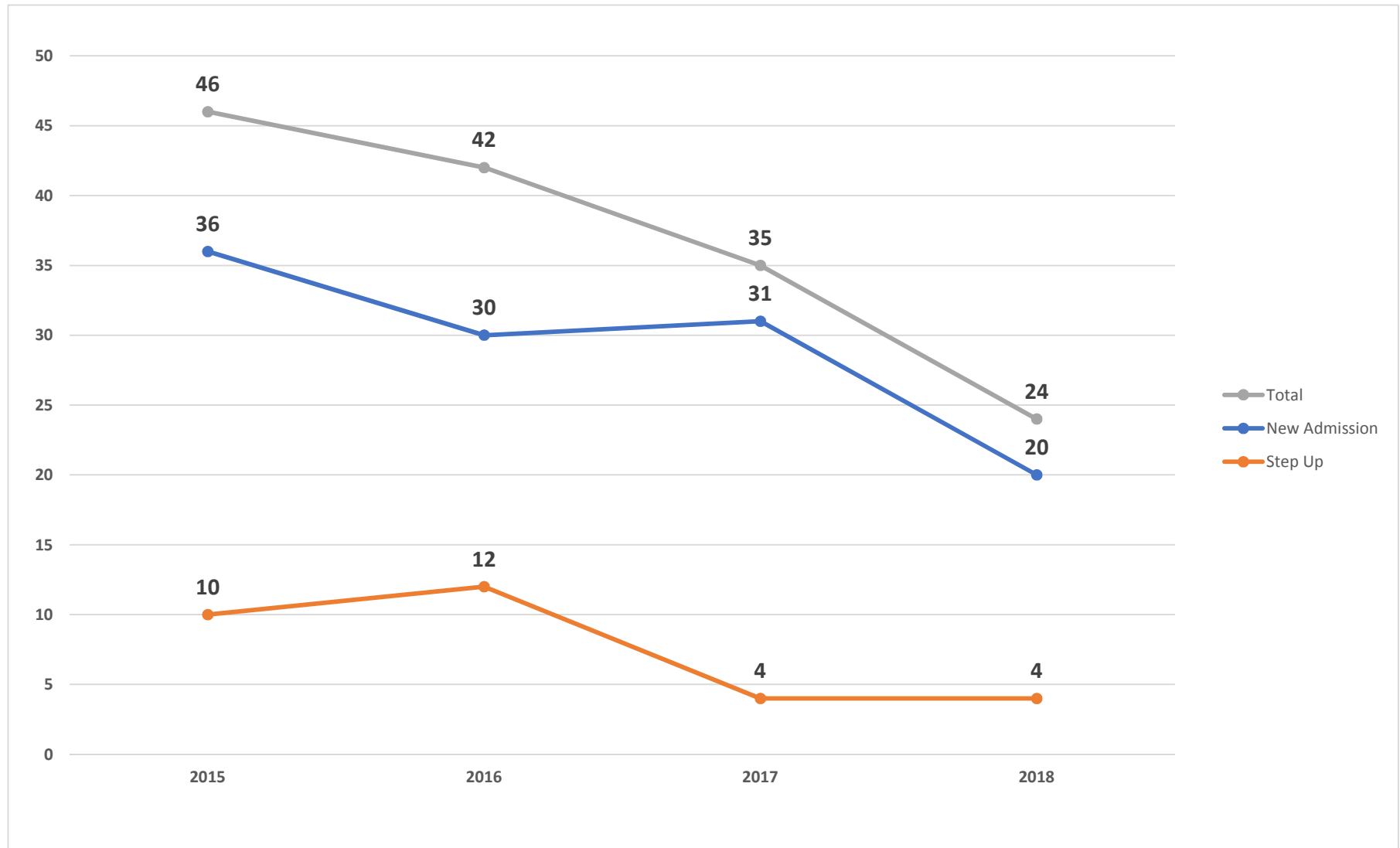

Figure 1. Movements into Congregate Care between 2015 and 2018, Rensselaer



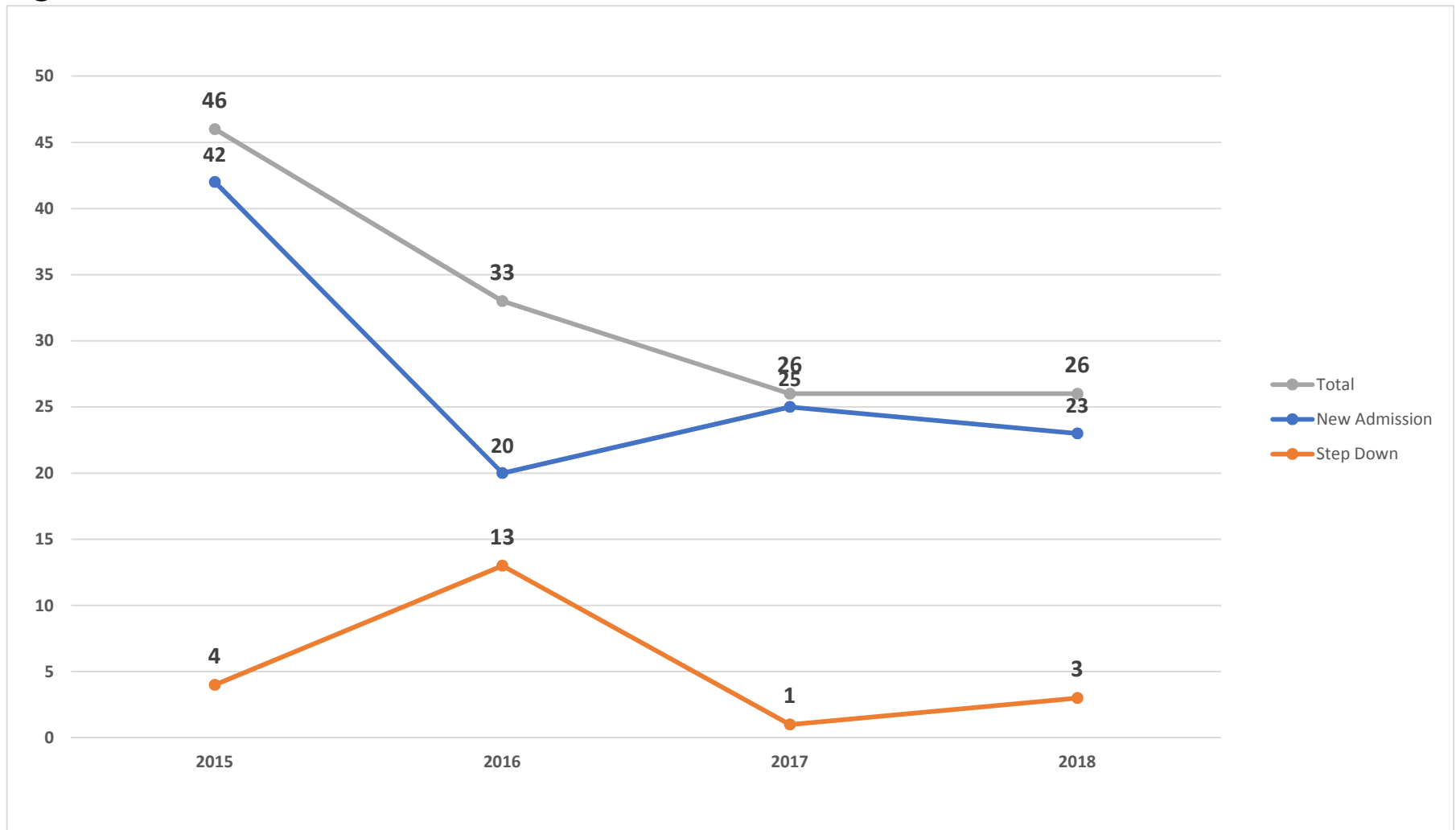
