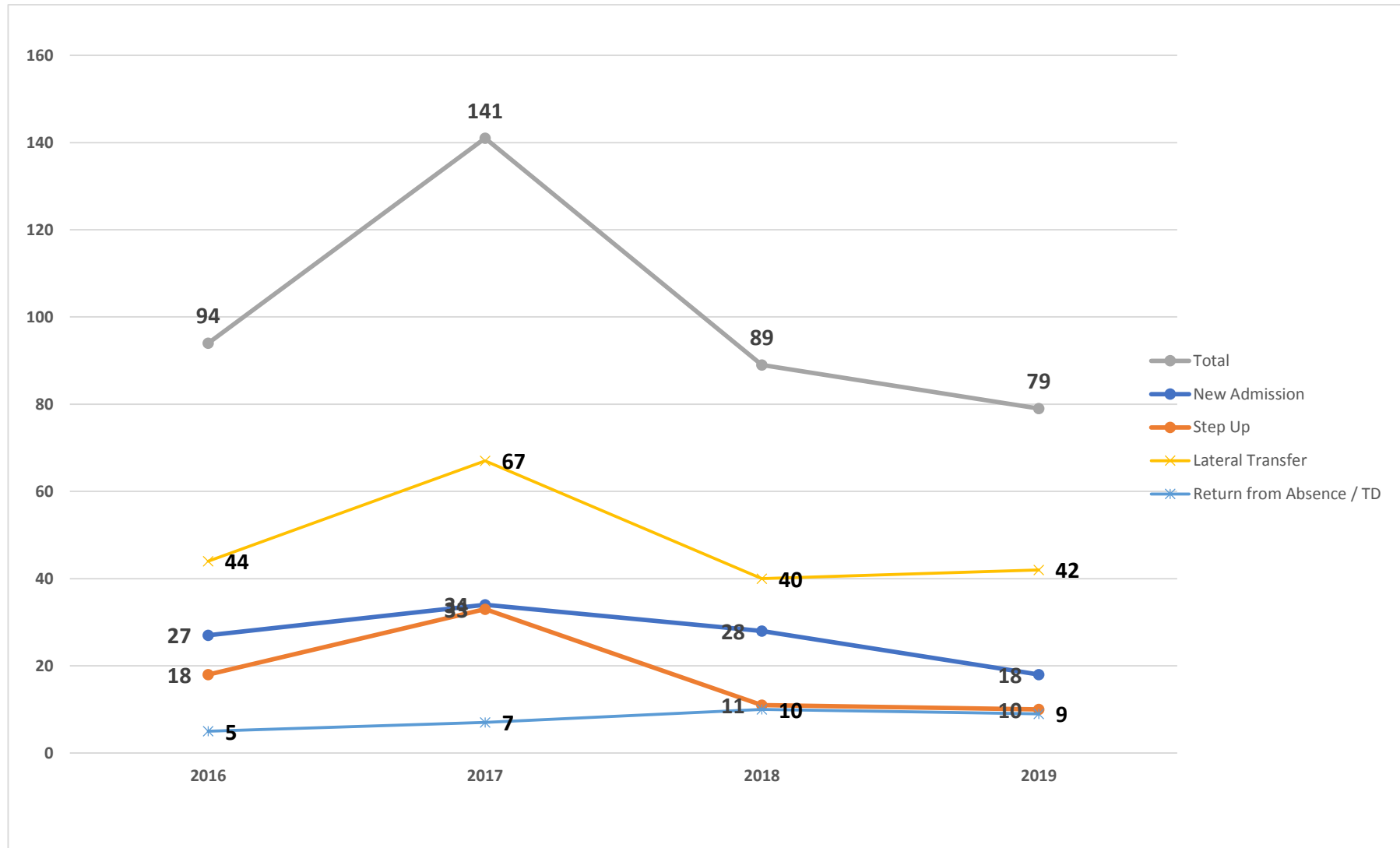

Figure 1. Movements into Congregate Care between 2016 and 2019, SCHENECTADY



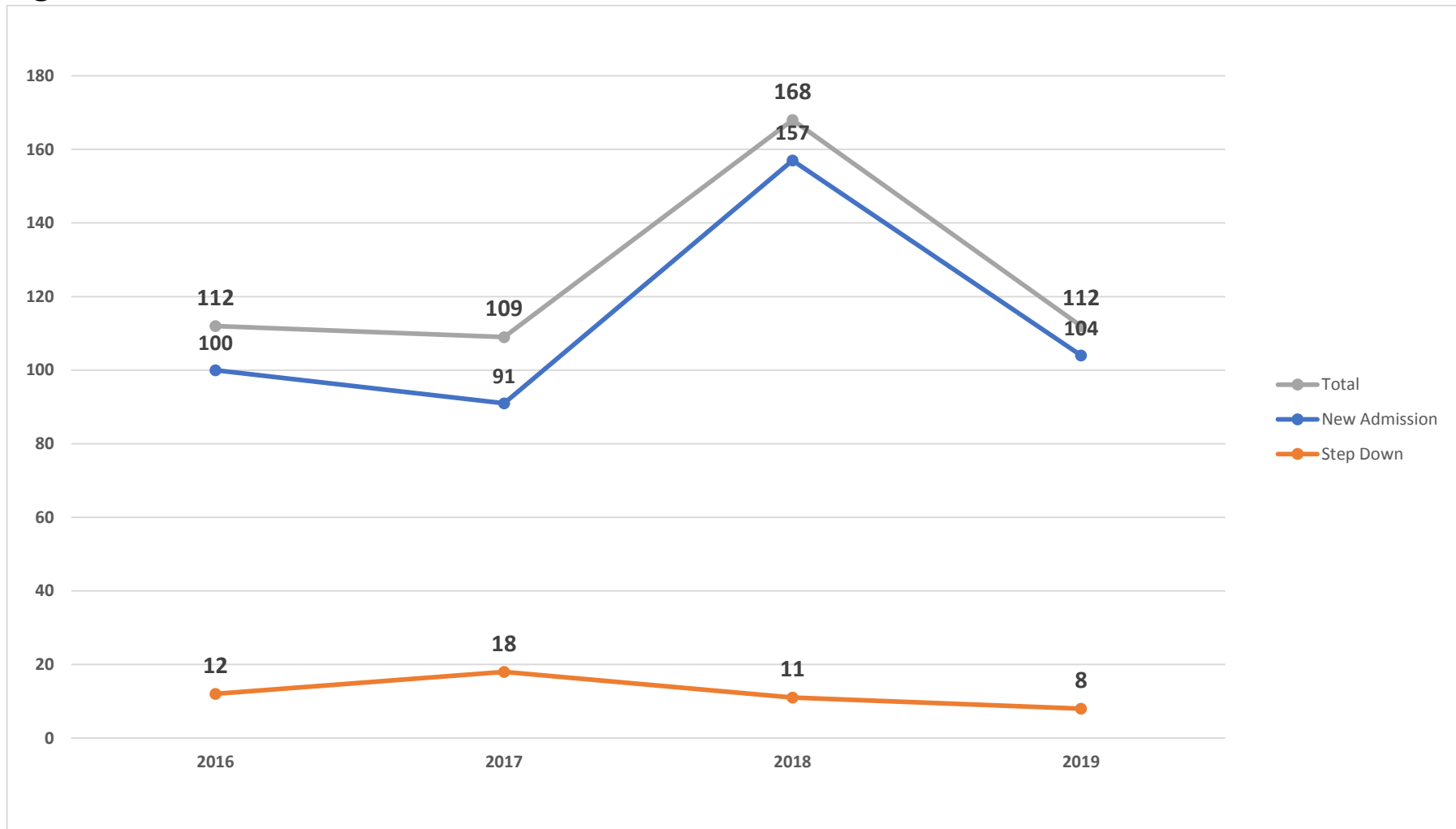
