This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

## Presenting Information

On 6/19/2022, Orange County Department of Social Services (OCDSS) received an SCR report which alleged the 12-year-old male subject child died while in the care of his mother. The mother had last seen the child around 10:30 PM on the evening of 6/18/2022, to take his electronic devices away prior to his bed time. The mother checked the child around 7:40 AM on 6/19/2022, and found him to be unresponsive. The mother contacted emergency services who responded to the home and found that the child was already deceased. There were no surviving siblings and no other children residing in the home.

## Executive Summary

This report regards the death of the 12-year-old male subject child which occurred on 6/19/2022. At the time of his death, the subject child resided with his mother. The subject child visited regularly with his father. There were no surviving siblings or other children residing in either home.

OCDSS received an SCR report on 6/19/2022, alleging the subject child had died sometime between 10:30 PM on 06/18/2022 and 7:41 AM on 6/19/2022. The report alleged the child was in the sole care of his mother and there was no explanation provided for his death.

On the evening of 6/18/2022, the subject child went to bed in his bedroom around 10:30 PM. Around midnight, the mother went to the subject child's room to remove his electronic devices, which was a regular occurrence. At 6:00 AM on 6/19/2022, the subject child's alarm went off. The mother went to the subject child's room to silence the alarm and the child did not wake at that time. The mother went back to sleep and woke again at 7:30 AM, at which time she checked on the child and found that he was very cold. The mother tried to move the child and found that he was stiff and heavy. The mother called 911 and called her family. EMS responded to the home and found that the child was deceased. During the investigation of the scene, the subject child was turned over and it was found there was some foaming of the mouth and a small amount of vomit.

An autopsy was performed on 6/20/2022. The medical examiner's office reported there were no findings during the preliminary autopsy to determine the cause of death. A toxicology screening was completed and was negative for substances. The final autopsy report was not yet available at the time this report was written, pending genetic testing and testing on the child's lungs; however, the pathologist at the medical examiner's office reported the child's death was likely to be ruled natural causes. The criminal investigation remained open, pending the final autopsy report; however, as of the closing of the CPS investigation, there was no suspicion of criminality related to the death of the subject child.

OCDSS conducted a thorough investigation of the death of the subject child. OCDSS made contact with, and gathered records from, pertinent and relevant sources. OCDSS maintained contact with the parents throughout the investigation and helped guide the family through the investigative process.

OCDSS determined the allegations and closed the CPS investigation on 8/12/2022. The allegations of DOA / Fatality and Inadequate Guardianship were unsubstantiated against the mother regarding the subject child. The investigation determination noted there was not a fair preponderance of evidence to support the allegations.



OCDSS offered bereavement services to the mother and father of the subject child; however, the parents declined those services.

### LDSS Response

OCDSS initiated an investigation immediately upon receiving the SCR report on 6/19/2022. OCDSS gathered information from the mother, father, law enforcement, the medical examiner, the subject child's pediatrician, the subject child's school, and extended family members.

OCDSS conducted interviews with the parents separately. Both parents stated the subject child was in good health and reported no knowledge of medical issues or illness that could have caused the child's death. Both parents denied substance misuse for themselves and denied any knowledge or suspicion that the subject child had ever used or misused substances. The parents denied concerns for each other's parenting or care of the subject child.

Information gathered from the subject child's pediatrician and school showed the child was in good health and was well cared-for by his parents. Neither entity reported concerns for the child's health or safety.

Documentation throughout the case record including interview summaries, investigative actions, and supervisory consultations were entered timely and accurately reflect the case circumstances.
